Case Study: Finding the Right Fit

375 County Road 39, Southampton, New York

CHALLENGE

The Southampton Retail Center, located at 375 County Road 39 in Southampton, New York, consists of five tenants in approximately 13,440 square feet of retail space. There were clearly defined challenges in selling this property. The first challenge being the Peconic Bay Region Transfer Tax. The purchaser of the building had to be willing to pay the 2% transfer fee, which narrowed our list of potential purchasers. Another challenge was that the lease of the largest tenant (Jennifer Convertibles, which brings most of the activity to the shopping center) was expiring in a few months. Many buyers were concerned that they would not sign a new lease, therefore this property came with substantial risk. Finding an all cash buyer willing to pay the transfer fee, and take the risk regarding the lease was a very ambitious brokerage assignment.

ACTION

Upon receiving my brokerage assignment, I immediately went to work sifting through my substantial database and took the additional step of contacting fellow brokers with whom I have developed great relationships with over the

My priority is always to get the seller what he or she wants, even if that means co-brokering a deal and splitting my commission. In this particular case, the seller of the shopping center had a large emotional attachment to the property since her late husband had built it in 1984. It was important to find the right buyer who the seller felt comfortable with. Together with CP Commercial Properties we were able to secure the perfect buyer.

RESULT
